### Financial Maintenance Actions:

Close current checking and savings with Chase Midlothian and move to Citizens National Bank Waxahachie.

This change will net a small positive growth of a few hundred dollars a year - saving fees and maximizing interest

1 Ease of maintenance for Pres/Tres

2 Currently we are charged fees with Chase, CNB we do not incur fees as long as balance is above balances above \$250 whereas chase requires 5000+ minimum or we are charged fees, this would allow us to maintain a smaller balance in checking and place remainder in savings maximizing interest return.

Tax Forms have been completed they were missing 2015 and 2016 which put us at risk for losing our non-profit status. - We are Current for 2017 and 2018.

Development of Dues Scholarship - 1 per year - no repeat years. - develop criteria. Will look at soliciting local nursing schools and parallel nursing/professional organizations

### **Education Service Plan:**

This plan was formalized and will adopted as the general outline for group educational activities. Careful consideration as been given so as not to interfere with the National or State conferences.

**Even years** - AAOHN national conference , ce courses, online - or in person such as (sanofoi pastuer flu training, select physical therapy lectures etc.) at least two offerings one in summer and one in fall

**Odd years** - AAOHN national conference, State conference. **Summer** CPR offering July / August.

(If there is limited or minimal participation - we will consider a scholarship for State or National Conference fees - 1 per year - no repeat years. - develop criteria.) Will need to be determined by September 1st.

## Elections:

Latha Frye/Lara Stahl will work collaboratively to bring resolution to the election process for 2019

Elections are set to take place this fall; We have not followed the elections process due to the change in leadership board in 2017. We should begin the revolving process described in our bylaws - as this ensures there is never a complete turnover of the organization leadership like in 2017. This year I suggest two positions. The seat Karen is occupying as she has communicated she will not run again and Mary's position should she decide to not run again as she expressed is a possibility- this leaves the other three incumbents in place at least one more year so we would have a break down like this:

#### Section 2. BALLOT:

- A. In odd numbered calendar years, the ballot shall contain nominees
  - (2 or 3 Leadership Board members ) Critical leadership positions (Pres, Vice Pres, Tresurer)/ titled positions
- B. In even numbered calendar years, the ballot shall contain nominees for: (2 or 3 Leadership Board members) untitled Directors Positions

#### Section 3. ELECTIONS:

- A. All elections shall be done electronically except when a paper ballot is requested by eligible members.
  - 1. The ballot, together with directions and the accompanying documents of each candidate shall be sent to members by Nov 15<sup>th</sup>.
  - 2. The election will be held the first week of December.
  - 3. The Treasurer shall ensure the Election Chairman receives an official roster of members eligible to vote to.
- B. Electronic voting results to be reported to the Election Chairman by (2) days postelection.

- C. Decision: A plurality vote shall elect. In the event of a tie vote, a decision shall be determined by lot.
- D. Ballots shall be retained for six (6) months.

We of course value the experience and commitment of all the board members so this decision is left up to the individual. The board will confirm desire of continued service/ resignation prior to moving forward with solicitation of membership for board candidates. As a courtesy please notify me before November 1st should you know you do not want to continue your service on the Board, as it is my responsibility as treasurer to provide Latha with an accurate list of members/candidates for the selection process
